In comparison to other well-known linguistic movements in India (like the Andhra or the Tamil movements), Orissa is the single instance of the imagination of a pan-regional linguistic identity that made a successful negotiation with the colonial state by using mainly constitutional means within the framework of colonial power. Subsequently, like many other linguistic movements that culminated in statehood in postcolonial India, its appeal waxed and waned and over the long run gradually declined in the second half of the twentieth century, as language came to be displaced by issues of development and underdevelopment as the prime movers of identity politics under electoral democracy. 

The spiritual life in Islam begins with 'riyadat al-nafs', the inner warfare against the ego. Distracted and polluted by worldliness, the lower self has a tendency to drag the human creature down into arrogance and vice. Only by a powerful effort of will can the sincere worshipper achieve the purity of soul which enables him to attain God's proximity. Inequality is a choice. The United States bills itself as the land of opportunity, a place where anyone can achieve success and a better life through hard work and determination. These trends are on track to become even worse in the future. Some economists claim that today's bleak conditions are inevitable consequences of market outcomes, globalisation and technological progress. If we want greater equality, they argue, we have to sacrifice growth. This is simply not true. American inequality is the result of misguided structural rules that actually constrict economic growth. We have stripped away worker protections and family support systems, created a tax system that rewards short-term gains over long-term investment, offered a de facto public safety net to too-big-to-fail financial institutions, and chosen monetary and fiscal policies that promote wealth over full employment.


