Scale in cities is relative and absolute. It has the ability to make us feel at home in the world or alien from it; connected or disconnected. Both large and small scale in cities can be beautiful; both are right, neither is wrong. It is also an anecdotal account of missed opportunities. The narrative begins with a chapter on the author's privileged childhood, her entry into politics, and the hurdles and struggles that she faced along the way as a woman politician in the male dominated society of rural Punjab. She provides details of the deterioration and erosion of the country's institutions. A unique insight has been offered on the rise of extremism. Pakistan's close embroilment in Afghanistan has been covered, beginning from the late seventies right up to the first decade of the twenty-first century. 
