	Further, Intake batch 2016 is also accredited under Level II of First Schedule subject to compliance on deficiencies weak areas / concerns mention in Criteria-3(iv, v).
	The committee showed serious concern in continuous violations pertaining to PEC Regulations on higher Intake more than allowed by PEC in 2017 and 2018. In this regard, a Show Cause is being issued to HEI on the said violation. Such violation is liable to imposition of Penalties as per article-8 of PEC regulation for Engineering Education.
